St. Francis Motorcycle Museum Ride By Becky Ackerman, Ride Coordinator

You will see by the Ride Book that Mike and I were to host this ride to St. Francis, Kansas in August. As it turned out we only had one other couple show any interest in joining us. And since we hadn't camped together all summer, we chose to take our motorhomes and leave the bikes at home. Tsk! Tsk!

We met Steve & Tami Bender in Bennett and from there cut across country through northeast Colorado and a corner of Nebraska to end up in St. Francis. We had lunch then toured this small but interesting museum. The following gives you a taste of what they have to offer.

"The St. Francis Motorcycle Museum houses more than 115 vintage motorcycles from more than 40 manufacturers including ACE, Cleveland, Jefferson, Emblem, Excelsior, Flanders, Harley-Davidson, Henderson, Indian, Marsh-Metz, Reading Standard, Pope, Thor, Yale, Feilbach Limited, Iver Johnson, and others.

"The museum is pleased to exhibit one of only two known 1902
Orient motorcycles; the earliest manufacturer to use the term "motorcycle." We also house 30 motorcycles older than 1929 (several of which only five or less are known to exist). The museum is a treasure of motorcycle history and memorabilia, and the collection is one of the finest to be found anywhere."



From there, we drove on to Goodland, where we spent the night in the KOA campground. We spent a long time in the pool as it was pretty warm! After a great dinner on the grill and more time to relax, it was a very pleasant weekend and long overdue for Tami as this has been a grueling summer for her at work.

Cherry Creek Encampment - A memorial to the Cheyenne Indians who survived the Sand Creek Massacre By Mike Ackerman, Social and Membership Enhancement Coordinator

Following the massacre of the Cheyenne Indians at Sand Creek on November 29, 1864, near the town of Chivington, Colorado, survivors made their way to a camp on the Smoky River.

The Cheyenne were so angry about the atrocities committed against their people that they sent around the war pipe at once. The pipe was taken to Spotted Trail and Pawnee Killer's Sioux, the Cheyenne Dog soldiers, and the Northern Arapahoes. In response, all of these tribes moved and camped on Cherry Creek. It is written that nearly 3,000 Indians gathered here.

On New Year's Day, 1865, the chiefs assembled in council and decided to attack Old Julesburg on the South Platte. From Cherry Creek, they set out, nearly 1,000 strong, to seek revenge and plunder the town where the Stage Company had a large station.

On January 7, 1865, the Indians attacked. After their successful coup, they loaded the plunder on their horses and in three days were back in the Cherry Creek encampment.

The Cheyenne, who had been mourning the great loss of their people at Sand Creek, took heart when their warriors returned with the goods they desperately needed. The camp on Cherry Creek was a scene of great feasting. Scalp dances were held and the young people danced until sunrise.

Meanwhile, the chiefs again gathered in council and decided to move north to the Black Hills and join the Northern Cheyenne, Sioux, and Arapahoe and ask them to join in the war against the whites.

It was from this historical site on Cherry Creek that the runners were sent to notify the tribes that they were coming, and criers announced the plans to all camps. This is where the Plains War between the Indians and Whites began, a war that lasted twelve years and culminated at the Battle of the Little Big Horn in Montana in 1876.

On September 9, 1990, a dedication ceremony in honor of the Cheyenne Indian survivors of the Sand Creek massacre was held at this site.

Descendants of those survivors, Cleo Wilson, son John Sipes, and family participated in the dedication. Cleo cried as she looked on the site, remembering the sufferings of her people as passed down through the oral history from her elders.

The memorial is located near St. Francis, KS: One mile west, one mile north on Kansas Highway 27.



Information Dissemination Eventations By Ralph K. Spencer III, Treasurer/Motorist Awareness Coordinator

Hello, avid MAP readers! I hope everyone had a relaxing Labor Day Weekend. I am always amazed at how the temperatures recede immediately following this weekend year-after-year. Hopefully, we have two more months of nice riding weather to look forward to. But I digress!

To begin with, I realize that I have a fake word in my title. I desperately wanted a three-word title and, when I could not find the word I needed, I made one up. I figured with all the fake news rampant in today's media, no one would pay any attention to my fake word. We shall see!

I read with interest a Motorist Awareness Program (MAP) article by Michael Olson, Assistant Director, MAP, in the September 2018 issue of *Wing World* (see the bottom of page 64). He pointed out various ways that Gold Wingers across the country are participating in unique Information Dissemination Eventations designed to get the word out to the motoring public to help increase awareness about motorcycles. Here is the list that Michael included in his article:

- Set up a windshield washing station and give away free bottles of water and MPA brochures;
- 2) Provide MAP coloring booklets with crayon packets to children (and MAP brochures to the drivers);

- 3) Hold bike shows at malls (and distribute brochures);
- 4) Participate in parades;
- 5) Give away bumper stickers (and brochures);
- 6) Put out road signs;
- 7) Make public service announcements on radio and/or television:
- 8) Attend swap meets/flea markets (and distribute brochures).

Michael went on to say that the Information Dissemination approach likely to have the most impact is personal contact. To use Michael's example, assume you are filling your tank with fuel and someone walks up and says, "What a beautiful motorcycle!" This scenario provides a golden opportunity to share what all riders and co-riders want the driving public to know - watch out for motorcycles! Michael encouraged Gold Wingers, and MAP coordinators specifically, to get on board and help with this extremely worthwhile Information Dissemination project. His last sentence grabbed me as I hope it grabs you: "Without knowing it, you may help save a life." Wow!
