## Law Tigers: America's Motorcycle Lawyers By Ralph K. Spencer III, Treasurer/Motorist Awareness Coordinator

No, this article is NOT a paid (or unpaid) announcement for the infamous Law Tigers, whose advertisements seem to be prevalent during many NFL and MLB televised games. I decided to give these folks top billing this month since they took the time to contribute three pages worth of interesting motorcycle tips and tidbits in a recent issue of *Wing World* (August 2018, pages 28-30). I would like to highlight some of the more interesting, and perhaps overlooked, motorcycle tidbits brought to light in this article.

To begin with, the Tigers point out that The National Highway Safety Traffic Administration confirms that the non-motorcycle operator is usually the at-fault driver in accidents where another vehicle violates the motorcyclist's right-of-way. This should not be a surprise to most of my readers. After all, we are all aware of that old adage: "The one with the most lug nuts wins" - even when they are in the wrong!

An equally disconcerting factoid presented by the Tigers is that motorcycle riders over age 50 are generally safer and involved in fewer accidents than younger riders. However, in the vernacular of Paul Harvey, the rest of the story is that riders in this age group are far more likely to face serious injuries and even death when they do get involved in accidents, as noted by *Consumer Reports*. Therefore, older riders should be more inclined to take preventative measures to enhance their own safety while enjoying a ride. The Tigers are quick to point out that the above information

may seem counterintuitive (yep, they're lawyers all right!). In non-lawyer-speak, why should the group of riders involved in the least number of accidents (the over-50 crowd) face higher risks?

The reason is, wait for it, that other factors play a role in these accidents. Factors, such as rusty riding skills, higher susceptibility to injury, reduced muscle strength, as well as a greater vulnerability to chest injury, may contribute to accidents or severe injuries. And here is a plug for mandatory helmet laws: Head and chest injuries are ranked high in severe motorcyclist injuries. A rider not equipped with the proper helmet is about 40% more likely to endure a fatal head injury in a motorcycle accident than a rider wearing appropriate head protection.

Finally, the Tigers provide some sobering information on motorcycle fatalities. The National Safety Council has released 2015 data showing that 35% of motorcycle fatalities were riders age 50 and older. Alcohol and speeding were also significant factors in fatal motorcycle accidents. The Tigers point out that while you cannot change your age, there are some changes you can make to your riding habits to reduce these risks. I will review these various safety tips in my November article. Until then, enjoy that good looking animal the Tigers continue to use in their television ads (Can you guess what it is?) and continue to Share the Road -Safely!!!





# Where did Halloween Come From?
